Your direct deposit needs to be a recurring electronic deposit of your paycheck, pension, or government benefit (such as SSI) from your employer or the government. The reward will be deposited directly into the new member's checking account within 60 days of meeting the offer requirements. Incentive may not be combined with any other offers. Minimum deposit required for membership of \$5.00. Minimum credit or risk score may be required to qualify for services.
